



## Licensure Table & Accreditation Notes

### About CSWE Accreditation:

The Master of Social Work (MSW) degree offered by Eastern Oregon University (EOU) is designed to meet the 2022 Educational Policy and Accreditation Standards (EPAS) from the Council on Social Work Education (CSWE). However, EOU's MSW program is not currently accredited by CSWE's Board of Accreditation (BOA).

The program aims to submit its Candidacy Eligibility Application and Benchmark I documents for CSWE staff approval by March of 2025. Once approved by CSWE staff, the program will be granted pre-candidacy status.

Pre-candidacy for a baccalaureate or master's social work program by the CSWE BOA indicates that it submitted an application to be reviewed for candidacy and received approval of its Benchmark 1 from CSWE accreditation staff to move forward for a candidacy review within 1-year. A program that has attained pre-candidacy status has not yet been reviewed by the BOA nor verified to be compliant with the EPAS.

Students that are admitted to pre-candidate programs in the fall (or later) of the academic year in which the program is granted candidacy status will be retroactively recognized as graduates from a CSWE-BOA accredited program as long as the program attains initial accreditation. EOU's MSW program should receive Candidacy status in June of 2025, however it is not guaranteed. Candidacy is typically a 3-year process and attaining pre-candidacy does not guarantee that a program will eventually attain candidacy and initial accreditation.

### About State Licensure:

Depending on the U.S. state or territory in which you plan to practice social work, a professional license or certification may be required. EOU's MSW program meets the degree requirements to pursue the Master's Social Worker license (LMSW) in Oregon, pending an applicant's successful completion of the ASWB Masters level exam, the Oregon Rules and Laws Exam, and other state requirements. It also meets the degree requirements for the Clinical Social Worker license (LCSW), pending an applicant's completion of supervised practice experience, the ASWB Clinical level exam, the Oregon Rules and Laws Exam, and other state requirements.

Educational requirements for social work licensure vary by state. State requirements are subject to change, you should review current licensure requirements in the state in which you intend to pursue licensure.
