Registration: All entries must be received by 4:30 p.m. on Friday, October 11, 2024. Drop off forms at the parade registration/check-in or email them to alumni@eou.edu.

Line-up: Check in/Line-up will begin at 4:00 p.m. at the corner of Fourth Street, between Adams Ave. and Jefferson St.

Parade Rules:

- Line-up begins at 4:00 on FOURTH STREET (between ADAMS AVE. and JEFFERSON ST.).
- Leave any vehicles in the Library parking lot or the parking lot across the street on Jefferson, next to The Observer), if needed.
- The Mountie March will begin promptly at 4:30 p.m. (look for EOU Staff and Alumni Board Volunteers for line-up order).
